In (Abi Tammam Alta'e) center

Have documented irregularities and notices below,

- 1-Two boxes have been stolen at night from the center.
- 2- Some individuals attempted to take advantage of the situation and placed boxes outside the center claiming that they are voting to decide the fate of Kerkuk to be annexed to Kurdistan region.

**I'm observer** (Guler Bakr Hasan)  
In (Alsadr high school) center

Have documented irregularities and notices below,

- 1-Groups of National Guards attempted to vote twice.
- 2-A fight broke out in the center between an observer and the chief of center because the observer tried to stop individuals from National Guards from voting twice.

In (Musallah high school for males) center And in box (31912 city council/31907 city council/31309 National council/31906 National council)

Have documented irregularities and notices below,

Witnessed in the 4th station that an Identification Officer giving some individuals more than one ballot paper, name of Identification Officer (Ali Amin wali) he is from Kurdish nationality.

All stations managers were from Kurdish nationality. A man from outside Kerkuk came to the ballot center to oversee the Kurdish arrivals.

Have documented irregularities and notices below,

Four boxes have been carried to unknown place with an excuse of having excessive boxes and ballot papers in (Mohammed Alsadeq) school.

(Province council box number 144571+2+3+4 lock number 14458)

Members of political entities and coalition list (130) came into the ballot center and guided people to cast their votes for list (130) of which they did not carry any authority from the commissioner.

**I'm observer** (Najat Said Zaynel)  
In the center (Menguli located behind Alkarama Security)

Have documented irregularities and notices below,

- 1- We were not allowed to participate in sorting out the ballots and have been kicked out of the center after 5 p.m.
- 2- Kids of under age (18) years old, cast their vote in the ballot.
- 3- Urging citizens to vote for the Kurdish list.

**I'm observer** (Omer Tahir Mohammed)  
In center (Mohammed Sadeq elementary school for females)  
In box (0173258+7+6)

Have documented irregularities and notices below,

- 1- Seen some observers, carrying green badges, interfering in voter's opinion and guiding them to elect according to their own personal opinions.
- 2- After finishing sorting ballots and closing boxes and officers leaving, saw at 10 o'clock evening that observers carrying green and yellow badges have not left the ballot center. Yellow badge holders are from Democratic Kurdish party and the green are from Kurdish Patriotic Union.
- 3- Some voters carrying (deported people papers) and adding their names to the list
- 4- Saw some voters have ink in their fingers and repeated casting votes for list 130.

**I'm observer** (Najdat Mardan Mustafa)  
In center (Alizdehar High school)  
In box (40440 number box National council/province council 4049)

- 1- Tent was erected for Kurdistan Union asking voters in front of the entrance door to vote for Kurds and were paying \$50 to whoever enters.
- 2- (5) individuals from Kurdish nationality added as observers without obtaining official permits from commissioner.
