A Reason of the Terror in the Occupied Iraq

It is well known to the international community when the Bush administration occupied Iraq in 2003 had no consideration or any foreseeing plan after the occupation. The USA soldiers behaved after occupation as conquers and not as democratic system bringers or liberator of the Iraqi peoples from Dictatorship. Furthermore, they had no ideas about the Middle Eastern and Islamic mentality, culture and tradition. In the streets, the ordinary peoples were treated inhumanly and cruelly. The houses are attacked in midnights in manners which are offensive to the Iraqi people; disgraceful, vindictive and humiliating. The international laws are severely violated in the prisons. ^{1,2} The chemical weapons are used inside cites. ³⁻⁵

Several months after occupation and with the increase of defiant from Iraqi people, the Bush administration compelled to depend on the two militant groups to build the so-called Iraqi National Guard. The Kurdish militant Pashamargas who fought the Iraqi state for decades. They have never got legal or regular military trainings. The Shiite Badr Army founded in 1980s in Iran. They were staffed by tens of thousands of pro-Iranian soldiers and trained and administered by the Iranian military school for 2 decades.

Tens of thousands of the Sunnis who are accused of being Ba'ath party members, militants or terrorists are kidnapped and killed or vanished by the illegal militant teams, 6 the occupation troops and Ministry of interior. 7 This had started the sectarian hatred much earlier than bombing the Shrines in Samarra. 8-10

The Turkmen are marginalized and their regions Kurdified and they remain under the mercy of the Kurdified administration and militants. Turkmen cities are repeatedly exposed to assaults by the Kurdish militants: in Telafer, ¹¹ Tuz Khurmatu, Erbil ...etc. This peaceful unarmed community remained loyal to the democratic manners in defending the national rights and avoiding the atrocities.

The raid on the Turkmen village Yengice presents a clear view about the nature of the so-called Iraqi National Guards.

Yengice is a village almost completely populated by Turkmen with about 15.000 inhabitants located 10 - 15 kilometers to the west of Tuz Khurmatu, which was exposed to sever systematic Kurdish emigration after occupation.

This village was frequently open to the elements of investigation by the Kurdish militants in the National Guard. They forced there way into the houses and searched every corner. They could not reach to the evidences of terrors. In January of this year, 5 of the inhabitants were taken to unknown region.

It was around 6pm of Friday 10.03.2006, the village was surrounded by the so-called Iraqi National Guard, which is almost entirely formed from the Kurdish militants. The village was randomly attacked by heavy artillery. The

announcements were made from the loudspeakers of mosques by Pashmargas ordering the people to remain in their houses or they will be shot on the spot if they adventure out. The operation was continuous for about 24 hours.

During the indiscriminate shooting into the village two inhabitants (32 and 26 year old) were killed and nineteen were wounded. The water supply and electric sources of the village were the first to be attacked. The main water tank of the village with another two smaller tanks was destroyed. Almost all the water tanks on the roof of the houses were shot and perforated. Electric generators were crushed. The electric cables and poles were demolished. Two houses were severely and another six houses were partially demolished. A shop was burned. The private autos, motorcycles and tractors of villagers were subjectively shot in front of houses. The licensed rifles, pistols and mobile telephones were confiscated. The villager's cattle, dogs and livestock's were killed. The villager's cattle,

By 12 midnight the houses were attacked and investigated, the inhabitants were beaten, and the children awaken in horror. The females who tried to protect their husbands were knocked down. To terrorize the inhabitants, the Guards shot the at the walls and the furniture

All types of furniture were smashed: from televisions, computers, cupboard, to mattresses.

The children were questioned about their father's weapons. A boy about 10 years old was beaten by boxes and the end of rifles when he answered that his father had no weapons. His tooth was broken and his nose started bleeding.

The destructive, ¹⁴⁻¹⁶ harsh and abusive behaviors of the occupation troops, the Kurdish and Badr militants are themselves terror acts which are creating the counterterrors from the start of the occupation.

 - 2 severely, 6 partially and 17 slightly damaged houses
 - 6 private autos, 3 tractors and 5 motorcyclists were destroyed
 - 3 licensed weapons of the staffs of the village dispensary
 - 3 private and 8 municipality generators were damaged
 - 1 motor to bring water from the well
 - 46 licensed rifles, 4 licensed pistols and 30 mobile telephones were confiscated
 - Almost all the water tanks of the houses
 - 5 cattle
 - 150 Iraqi dinar and 58 gold from different house were lost
